Thank you for your interest in this exciting event. Please carefully read the details of your participation below. Space is limited and on a first come, first served basis. **Preferential registration is given to 2017 "Brand" vendors until March 31, 2018** (i.e. LuLaRoe, Tastefully Simple, etc.). After that date, registration is open to Brand representatives – first come, first served. We look forward to working with you!

**Time: Saturday 10 a.m. – 4 p.m.**

**Set Up: Friday from 4:30 – 6:30 p.m. OR Saturday 7 a.m. – 9:30 a.m.  
Your vehicle must be cleared of the display area by 9:45 a.m. on Saturday morning**

**Break Down: Saturday 4 p.m. – 4:30 p.m.  
Crafters/vendors must stay until the end of the festival or may disqualify for future participation  
Under NO circumstances will vehicles be allowed on festival grounds PRIOR to 4:00 p.m.**

**Fee: \$50 per 10x10 space (\$75 for end/corner space) \***

\* **Early Registration Discount: \$10 off for vendors/crafters registered & postmarked before May 1, 2018**

Booth spaces will not be reserved until full payment is received. NSF checks will be charged \$20. No refunds after September 1, 2018. You will receive a confirmation after it is received. This festival is "rain or shine". No refunds due to inclement weather.

No sales of knives, lasers, guns, or any other items or acts not mentioned herein which might be considered in violation of the laws and/or the rules and regulations of The United States Government, The State of Connecticut, New London County, The Town of Preston and/or the PCCC Scarecrow Festival and its organizers. No smoking or pets allowed in or around tents/booths. No alcoholic beverages allowed at any Scarecrow event.

All vendors or crafters selling consumable goods must carry their own insurance with a copy sent in with their registration. Food vendors are extremely limited as the church is the primary "vendor" of food for the event. If you have any questions about your goods, please call the church for additional information.

The PCCC Scarecrow Festival and its organizers is/are not responsible for any injuries, damage to, or loss of any items prior to, during, or following the Festival. The vendor is responsible and shall reimburse the Scarecrow Festival for any damage, loss, injury, or liability incurred by The Scarecrow Festival and/or its organizers or attendees caused by actions of the vendors prior to, during, and following the Festival.
