#### **Park Maintenance and Development:**

- A. Brosnan stated that there are between 100 and 200 geese presently at the Park and she emailed members all the previously discussed ways to eliminate their presence.
- P. Jankowski asked what was the best solution the Commission previously came up with.
- A. Brosnan answered the coyote decoys were put out but they only work for a short time, the swan decoys did not work. The USDA program was not popular with residents.
- P. Jankowski asked what do other towns do?
- A. Brosnan answered that the problem is never brought up at regional meetings, but she can reach out to other towns.
- P. LoPresti noted that the pond/water is causing the problem
- A. Brosnan thought it was not 100% the pond because when there is no water in the summer and the geese are still there.

Chairman Turner asked if the Town received the STEAP Grant funds.

A. Brosnan answered no.

#### **Unfinished Business**

#### Soccer field

Chairman Turner talked with New England Rush who proposed;

practice and game time for 2 teams for end of February to the middle of July

4 hours of practice a week

10 games played on Preston's field and a few skill clinics

In exchange they will give Preston goals (used 1 Season), replace nets and paint lines on the field

Preston youth will get free admittance to clinics

Parks & Rec will maintain the grass with extra fertilizer. To start on on the soccer field and if it work out well then do the softball fields as well.

A. Brosnan thought Rush would be paying for the fertilizer and noted that P&R did not budget for it. Chairman Turner did not think he ever indicated RUSH would pay for the fertilizer

Parks & Rec will reserve the right to shut the field down for maintenance.

Parks & Recreation Regular Meeting – teleconference January 26, 2021

Chairman Turner noted that this will leave the field open for middle school, Preston Parks & Rec soccer, an actual soccer field for Sky Hawks.

Chairman Turner suggested putting a sign in the parking lot indicating the fields and complex are managed by Parks & Recreation and showing the phone number for scheduling use.

#### Discussion:

R. Tucker stated that if we had to buy the goals they are \$6,000 each

To re-net a goal is \$500 and the paint is \$100 a can

K. Iozza stated that it is a great organization and having a soccer field will benefit the Town. The girls on the Rush team will help teach the younger kids how to play the game.

A. Brosnan asked if this is all in writing in a contract.

Chairman Turner answered he just has a proposal.

- A. Brosnan stated if we are exchanging services we should have the Town look it over and see if we need a legal opinion.
- P. Jankowski asked if there is a safety issue with people walking the track while the league is down there.
- R. Tucker answered there is no real safety issue. Several surrounding towns have soccer fields and people will walk the track as a soccer game is going on and there's never been an issue.
- K. Demara stated that it is not anymore of a risk than softball/baseball. It is common to have tracks around fields.
- A. Brosnan asked what are you asking people to agree upon because we haven't seen anything in writing

Chairman turner stated that I am asking them to agree to move forward with this suggestion to a contract.

A motion was made by K. Iozzia and seconded by R. Tucker to push this forward for further discussion of the soccer field.

All in favor. Motion carries.

A. Brosnan noted that the rates used for the past 2 years and asked if the Commission thought they should be raised.
